We wish to update on following matters :-

#### The Contract Value

The total amount of the Project announced as RM1,902,530,902 (Ringgit Malaysia: One Billion Nine Hundred and Two Million Five Hundred Thirty Thousand Nine Hundred and Two) is a ceiling value. The value may be revised subject to the finalisation of the scope of the Service Agreement due to be concluded by end of April 2019 between Mesiniaga Berhad and XiddiG. Any changes to the scope of the project will be made through the issuance of variation orders.

#### Duration of the Project

Subject to site readiness and the completion of pre-requisite activities, both Mesiniaga Berhad and XiddiG have agreed in principle that the project timeline which would be based on the finalised scope in the Service Agreement be extended to 31 March 2021.
